Summer School

The board of education shall sponsor a summer school program providing remedial and enrichment courses, when appropriate, at all levels and review courses at the secondary level.

Admission

Attendance in the summer school shall be on a voluntary basis, except where required by other board of education policy. Transportation will be the responsibility of the parents or guardian, except for students enrolled in special education programs.

1. Elementary

Admission to elementary summer school classes will be limited to those students who will be limited to those students who will be enrolled in grades K-6 in September of the year of the summer school session and who are current residents.

2. Secondary

Admission to secondary summer school classes must be approved by the superintendent or designee. Credit for courses not offered by the school district may be granted with prior approval from the high school principal.

3. Tuition

All services of the summer school program will be free to residents. Non-residents will be required to pay fees as established by the board of education.

INSTRUCTION

Summer School

1. The purposes of summer school are:

- a. to provide Montville students an opportunity to make up the required subjects which were taken during the school year and failed for the year;
- b. to provide enrichment to a student's academic program;
- c. to provide opportunities for growth to special education students;
- d. to provide remediation for certain students.

The Board of Education upon the recommendation of the superintendent at the March regular meeting shall decide course offerings for the summer session.

2. Attendance

- a. In order to receive credit for the course, a student cannot miss more than two (2) class sessions. This includes all reasons.

3. Discipline

- a. Instructors are not expected to tolerate discipline problems in the classroom. Continued misbehavior or tardiness will result in loss of credit and removal from the course.

4. Dress

- a. Students must dress in a manner which will not disrupt the classroom.

5. Transportation

- a. Students are required to supply their own transportation to and from summer school.

6. Enrollment

- a. The goal is to have classes with an enrollment with a minimum of ten (10). Smaller classes may be held with the approval of the superintendent.

7. Grades/Credit

- a. Where applicable a final grade and credit will be awarded upon successful completion of the course.

8. Supplies and Textbooks

- a. Supplies and textbooks will be provided to summer school students in the same manner in which they are supplied during the regular school year.

9. Elementary - Junior High

- a. The summer session will consist of twenty (20) days with two (2) hours per day for classwork.
- b. These classes will fulfill the requirement for summer school as listed in the attendance policy.
- c. All students will be graded on a pass-fail basis.

10. High School

- a. A student will be given credit for successfully completing sixty (60) hours of classroom instruction. The student must have had at least one hundred twenty (120) days in attendance and could not have dropped the course during the school year.
- b. All students will be graded according to the grading system used during the school year.

11. Other summer schools

- a. Students may attend summer schools in other communities or schools. To receive credit in Montville such programs must have prior approval of the principal and must meet all of the requirements as listed in paragraphs IX and X above.
